CSI: Green Bay

The City of Green Bay has hired 6 Community Service Interns (CSI) to provide neighborhoodbased public services to residents of downtown Green Bay. Working in cooperation with the Parks, Planning and Police Departments, CSI duties include directing residents to resources, educating on issues and ordinances, providing community outreach support, walking through downtown neighborhoods and parks to identify and address potential problems, and reporting issues or incidents to City personnel. The interns will also be a resource to community centers and neighborhood associations in an effort to strengthen the connection between neighbors and City Hall. The CSI's will be wearing gold shirts and jackets with black pants with the City Logo and CSI insignia in view. If you see them, please introduce yourself and welcome them to the neighborhood.

Astor Holiday Activities:

Though there is a chill to the change in seasons, many holiday and wintertime activities have been planned to warm the hearts of Astor neighbors:

Luminaries: On the four Saturdays of December (the 4th, 11th, 18th, and 25th), we encourage neighbors to place luminaries on their front walks or drives. A luminary may be a paper bag, a tin can, or a glass jar with a candle inside. The greater the participation, the more beautiful our neighborhood becomes to those walking or driving through. Alderman Update

- City and County budgets for 2005 are being finalized. There are always pressures on local government to increase spending in many areas. However, in fairness to the taxpayer, we must prioritize and concentrate on providing the basic services efficiently.
- St. Vincent's parking ramp expansion has been tabled at their request. They will be working with the city, the neighborhoods and Bellin to explore parking alternatives.
- Vetter Denk Architects have made proposals for major developments in downtown Green Bay. The City Council voted unanimously to include these concepts in the Comprehensive Plan. Construction on the first phase, the Riverfront Lofts condominium project, should begin next year.

Public Nuisance Initiative

The City of Green Bay is determined to eliminate public nuisance properties and is in need of our help. Public nuisance properties are properties that not only detract from the quality of our neighborhoods but are also a financial burden to the city. We all pay for the increased police, inspection and public works services needed for these problem properties. In response to this costly challenge, the Mayor has created the Public Nuisance Action Team. The members of this team are from the Neighborhood Division, Police Dept, Inspection Division and Law Dept. The PNAT identifies problem properties and with a unified approach quickly resolves the issues either through owner/tenant resolution or via circuit court. Since the fall of last year, the team has successfully brought over 25 public nuisance properties into compliance. A public nuisance property would be one in which there are numerous police issues as well as blighted housing conditions. These are the worst of the worst. If you are aware of a property that would be considered a public nuisance, please contact the City of Green Bay's customer service line at 448-3000.
