Sidewalks will be left in, where possible.

Concerns expressed about crossing Monroe Ave. for school children at Aldo Leopold or Howe. Traffic speed control/calming suggested. Unaware of anything planned from Cass St. south to the city limits. Krissy will send a PDF file of the blueprints.
