- a. Update from Officer Paul Van Handel: absent
- b. Update from City/County Representatives:
- Cheryl Renier-Wigg (GB Neighborhood): met with rep. of St. Vincent Hospital concerning the house that was torn down within the hospital corridor, and St. V's was *strongly* encouraged to communicate better with the city and the neighborhood associations.
- Alderman Bill Galvin: encouraged St. V's to do some things to hinder employees from jaywalking on Porlier. Now, we don't know if Webster will be redone by the Hospitals. Allouez plans to close the bridge to redo the bridge near Schroeder's Floral next year. Presently, city roads replaced at 1-2% per year, and some assessment to the property owners. A proposal to have "wheel tax" instead of an assessment, and a wheel tax would allow the city to do twice three times the amount of road replacement.

City might be reconsidering a partnership with Tundra Lodge for an Olympic sized pool (Tundra had pulled out of the discussions), and have a smaller Colburn pool.

- Some lead pipe investigations being done in the neighborhood. Water utility is replacing some lines already. 5-7 year plan.
