3. Announcements, Committee Reports and Special Guests

- a. Update from Officer Paul Van Handel: Over 300 notices sent out to potential speeders near Aldo Leopold, and more speeders pulled over. Astor Neighborhood, and some others, have avoided the crimes showing up in other areas of Green Bay. Construction begins Mon. May 23 on Riverside (Grignon to Hwy 172).
- b. Update from County Supervisor Erik Hoyer: now chr. of Human Services. Unaware of corp. Counsel leaving and pay out, until seen in the newspaper.

Update from Alderman Bill Galvin (district4@greenbaywi.gov): deep construction on Webster in front of the Bellin/St.V. hospitals. Baird St. might get busy with short cuts. Concerns with St. V. about the house they bought and tore down on Clay St. (violate corridor agreement?).

Coburn Park pool: Tundra Lodge bought 7 acres, to build a massive pool facility. Would let the public use the facilities, and charge fees. Donors have given \$1 million for a Coburn pool, and the city is now debating how fancy of a pool will be built at Coburn.

Ethics committee: Bill Galvin is the only Alderman on the committee.

Astor Park shelter: neighbors do not want a rebuilt shelter moved to a different area. Do not want a parking lot in that area.

Seems like city will go to a binding multi-layered referendum on the Lambeau extra tax money.

- c. President's Update GBNLC (Deby Dehn): 39 mini grants awarded, 4 not. ANA didn't get one. Submit special events to Park Dept. Now need liability insurance for events.
- d. Newsletter (Jen): next one to come out in late May.

4. Old Business

- a. Website (Eric V.): Eric repaired our hacked website. Many websites were hacked due to a recent Wordpress vulnerability (that has since been fixed). ANA Board photos and bios still needed. Events are being updated.
- b. Howe Family Dinner May 2^{nd} (Deby, Debbie, Nicole): was very disorganized. Not expecting to cook, in addition to serving. Next time, a sign noting ANA sponsorship should have been done. ANA paid for the meal (about \$300, serving 270 people).

c. Historic Preservation (meeting tomorrow night in City Hall, Ron and Nicole attending): planning to turn a present 7 page statute into a proposed 12 page statute.
