c. Alderman Bill Galvin:

- Dog park: presented details about the Whitney Dog Park as an example. Would we want more smaller pocket parks, or a few larger regional parks? Pocket parks either at Astor Park, or under the bridge or around East River? People seem to be picking up well in the pocket parks. ANA support, both verbal and financials, would be sought.
- Historic Preservation Committee ordinance proposals: going to Planning soon, and then City Council. Looking for Astor residents on a future committee.
- A lady would like a conditional use permit (CUP) by the Not by Bread Alone (original), corner of Porlier and Jackson. Would prepare and deliver meals. ANA board is supportive.

4. Old Business

- **a. Easter Egg Hunt** was held on Sat. March 31 at St. James Park. Fantastic group of volunteers, in snowy weather. Empty Easter eggs needed to be stored somewhere.
- **b. Historical Lamp Post Grant** approved, \$3000 mini grant. 50% from GBNLC, 25% from owner, 25% from existing neighborhood funds. \$400 total maximum. Deby Dehn will put a newsletter article together to explain the details.
- **c. Popcorn Popper** taken in for repairs in early May. \$75 diagnosis fee paid, which will apply to repairs.

Pastor Schleis is willing again to get the supplies, help set up and take down the stand, and help work the stand as needed. Ron is putting a list of volunteers together.

Can do hot dogs only 3X, to not violate food laws. Will also need to check for insurance coverage for the ANA Board.

- **b. Beer Garden** Weyckers have agreed to host, and provide the beverages. Sat. June 23. Food: brats, burgers? Tickets on Eventbrite (fee is 2.5%, plus \$1 ea.)? Would rather have personal contact with neighbors in this event. Square or PayPal were mentioned, too.
- **c. If Homes Could Talk** Tickets on Eventbrite. Brown Co. Historical Society will do most of the work. Sept. 15. Volunteer homes are asked to commit by August 01.
