The #1 priority was Historical Protection:

- prevent McMansions
- -retain historic integrity of existing homes
- develop resources (perhaps lectures, references) to help people maintain their historic home
- be knowledgeable and reasonable about City initiatives

The # 2 priority was Social Involvement:

- educate to lead residents to ask for help

The # 3a priority was Neighborhood Safety:

- promote the Porch light initiative
- invite neighborhood watch leaders

The # 3b priority was Neighborhood Physical Improvement:

- sidewalks

Mike Troyer and his assistant will collate all the sticky notes and discussion of the evening, and put together a plan based off that input, for a future ANA meeting.
